2. Planning applications received

 a. 20/0389/FUL Broadhayes, Toadpit Lane, West Hill Applicant: Ms Dawn Ayling

Construction of a new dwelling accessed by new drive with improved shared access (renewal of permission 16/2968/FUL)

Cllrs discussed the application and raised a several concerns regarding the close proximity of the trees and proposed dwelling.

Cllrs considered that the trees marked in yellow on plans will have significant concern for the occupiers of this proposed house and that there will be pressure to remove these trees in future. The concerns involve loss of light and fear of falling onto the property. The loss of these trees would have a major impact upon amenity of Toadpit Lane.

Additionally the trees marked in purple on plans are to the south of the proposed property and will restrict sun and daylight to the property for most of the day. There will therefore be pressure to also remove these trees which will open up the site and be detrimental to the local amenity.

Cllr QT noted that a detailed tree report had been submitted.

Cllr Cook reported that the trees had been recorded in the Special Trees of West Hill report and considered that the area of influence shown on plans for the yellow trees is insufficient considering their size.

In summary Cllrs did not support the application and considered that it would be appropriate to impose a TPO on all trees on the site.
