EXMOUTH: **No Waiting At Any Time** on specified lengths of Keats Close, Moorfield Road, Richmond Road, Salterton Road, Shakespeare Way and Trefusis Place; **Loading Only At Any Time** on a specified length of The Royal Avenue;

HONITON: **No Waiting At Any Time** on specified lengths of Battishorne Way, Chapel Street, Gloucester Close, Honiton Bottom Road, Joslin Road, Rosemount Lane and Weatherill Road;
